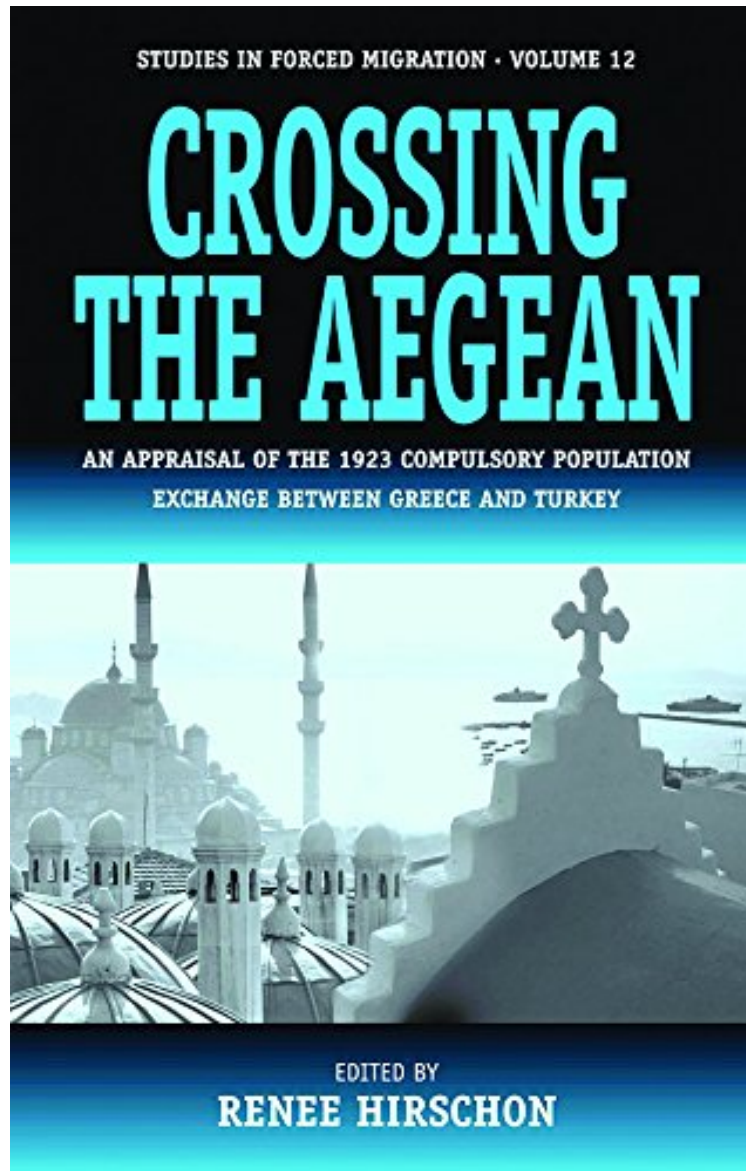

Based solely on the level of the scholarship, I would rate the book as 5 stars.By Bayard B.Very dull! Pretty heavy reading for the most part. For that reason, I gave the book 3 stars. The book is written by academics, pretty much with an academic audience in mind, I think. The author or editor of the book is a professor at Oxford in the UK. All the chapters are written by scholars (apparently all of them Greek or Turkish) who specialize in the area of the subject of the chapter. I suspect that a lot of them probably wrote their PhD theses on the chapter topics. Based solely on the level of the scholarship, I would rate the book as 5 stars.I found a couple of the chapters reasonably interesting. Chapters 1 and 2 give an historical overview of the subject. For someone like me who knew only a little about it, they were very informative. Then there were a couple of interesting chapters on the social and economic impacts of the refugee issue /population exchange on Greece and Turkey nationally.After that, things kind of go downhill. Chapter 12 discusses the architectural aspect of housing in Macedonia for the refugees from Turkey. Not particularly exciting! Chapter 13 discusses the settlements of Cappadocian Greeks displaced from central Anatolia to new villages constructed in Greece. The chapter describes items such as the new churches and cultural centers that were constructed. Chapter 18 discusses the impact of the ethnic Greeks displaced from Asia Minor on Greek classical songs also not particularly exciting.

Following the defeat of the Greek Army in 1922 by nationalist Turkish forces, the 1923 Lausanne Convention specified the first internationally ratified compulsory population exchange. It proved to be a watershed in the eastern Mediterranean, having far-reaching ramifications both for the new Turkish Republic, and for Greece which had to absorb over a million refugees. Known as the Asia Minor Catastrophe by the Greeks, it marked the establishment of the independent nation state for the Turks. The consequences of this event have received surprisingly little attention despite the considerable relevance for the contemporary situation in the Balkans. This volume addresses the challenge of writing history from both sides of the Aegean and provides, for the first time, a forum for multidisciplinary dialogue across national boundaries.

She is currently Senior Research Fellow at St Peter's College University of Oxford, Senior Member at St Antony's College University of Oxford and Research Associate at the Institute of Social and Cultural Anthropology, University of Oxford.
